## HBA Student Registration Form

August 2009 - May 2010

**TUITION:** All tuition is payable in advance and due by the 5<sup>th</sup> of every month. If paying after the 5<sup>th</sup>, add a \$5.00 late fee to your tuition payment. A fee of \$20.00 will be charged for checks returned "NSF." Monthly fees are calculated and prorated over the school year, taking into consideration holidays and months with five classes and will remain the same for every month unless notified by Dance Island.

**MAKE-UP CLASSES:** No tuition adjustments can be made for absences.

**WITHDRAWAL:** Dance Island should be notified in writing two weeks prior to withdrawal. You are responsible for two weeks of tuition payments after withdrawal notice, even if your child is not attending.

**ADDITIONAL COST:** *Registration:* An annual \$5.00 registration fee is payable every August.

**BEFORE AND AFTER CLASS:** Dance Island, Laura Kunimura and her teachers, and Hawaii Baptist Academy cannot be held responsible to supervise children waiting before and after their class. Students may enter the auditorium 15 minutes prior to their scheduled class and wait quietly. No student may enter the auditorium prior to 15 minutes before the beginning of class. Unsupervised students cannot wait outside the auditorium. Students should proceed directly to the auditorium. Students must leave the HBA campus as soon as possible after class is over or check into the HBA After School Care Program (ASCP). Loitering is not permitted on school grounds before or after class.

**HAWAII BAPTIST ACADEMY POLICY:** Children who are not registered in the HBA ASCP are not allowed on campus unsupervised. If students must wait before or after their dance class, supervised care is available for a drop-in fee. Call HBA's ASCP at 533-1106 for more information.
